- Controlled Blasting will continue until fall 2020.
- Sureway has cleared trees/topsoil south of OBCR & has begun digging gravel to lower grade in prep. for construction work.
- No complaints from residents around gravel/truck work.
- Graham Construction has been awarded DB2 south section, OBCR to HWY 8.
- North of OBCR banks are complete and top soil is being put back in prep. for hydro-mulch.
- Concern around wildlife fencing: where, what will look like.
- New AT liaison for CA's and residents.
- Graham Construction will have prelim. design for south portion. Discussion around getting involved with the design of paths/sidewalks at OBCR and Bow Tr. intersections for pedestrians/cyclists.
